Silver Willow Campground Rules and Regulations

Designed For Silver Willow Club Members and Clients
These Rules and Regulations are subject to change without notice.

- The Silver Willow Pheasant Farm LTD, its campground and its agents, servants, land owners, employees and or representatives do not accept responsibility for personal injury or loss of personal property of its guests. Please ensure all your valuables are in a safe place before retiring or when leaving your RV unit unattended. All facilities are used at your own risk.
- 2. Please drive slowly (5 km/hr) at all times watch for children playing.
- 3. ALL campers, their guests and/or visitors must be members / shooting competitors / instructors or connected in some way to Silver Willow Sporting Club. They must sign in at the Silver Willow Office as soon as they arrive at the campground.
- 4. Off Season Storage of a RV, may be available under a separate agreement.
- 5. Campsites are provided with ONE picnic table
- 6. ONE RV unit and ONE vehicle are permitted per campsite and must be contained to your own camp site. RV units include motor homes, trailers, 5th wheels, truck campers, and tents. Truck campers must remain on the vehicle at all times.
 - One tent per site may be placed adjacent to the camping unit. Please get approval from management.
- 7. Any and all camp site usage of the current camping season is considered to be for recreational camping purposes only and is not considered to be used for primary or permanent residency.
- 8. No person shall damage any campground property or make any alterations, improvements or modifications to the campsites.
- 9. All visitors must leave by 10:00 pm
- 10. Campground gates will be locked from 11:00 pm until 8:00 am if for any reason you need in or out within these hours please use your main gate access card / code.
- 11. All campsites must be kept neat and in clean condition at all times. Any camper who leaves a campsite in an untidy condition requiring additional maintenance for cleaning will be held responsible for the cost of such clean up. Any items that remain on a campsite after checking out becomes the property of Silver Willow.
- 12. Removal of any item from campsites may be requested at any time due to maintenance or safety concerns.
- 13. ALL RV units and vehicles in the campground must have valid registration and insurance.
- 14. The campground rules and regulations apply to everyone, whether you are camping for the entire current summer season, for the day, for the week, or for the month. Campers

- who fail to abide by or abuse the campground rules and fail to cooperate with campground management will receive notice to leave.
- 15. RVs, camping vehicles and trailers must be parked head in or head out only. No sideways parking will be permitted. RV towing apparatus must be made accessible in case of emergency or removal if necessary.
- 16. Single night reservations may be made for any night Wednesday and Thursdays during the Silver Willow hours of operation.
- 17. Weekend reservations require a minimum of 2 nights stay Friday and Saturday.

 Unless approved by the campground manager. Long weekend reservations require a minimum of 3 night stay Friday, Saturday and Sundays unless approved otherwise.
- 18. All arrivals must occur during the Silver Willow operating hours, unless pre-arranged for special reasons.
 - Wednesday and Thursdays 9:00 am 8:00 pm
 - Friday, Saturday and Sunday 9:00am 5:00pm
- 19. Sound Generating Devices. Occupants Shall comply with all applicable laws, ordinance, rules and regulations respecting sound control and noise levels, and shall be responsible for controlling noise while at the campground. Management reserves the right to require the removal or turn down the volume of any generators, stereos, or other devices that generate noise deemed to be excessively loud by the manager.
- 20. Small, self-contained propane fire pits are permitted at your site on the gravel area.
- 21. Garbage is to be put in plastic bags and placed in the containers provided nearest your campsite. Items such as microwaves, furniture, BBQ's etc. are not to be disposed of in these dumpsters. For disposal of these items please use the main landfill site. Directions and contact information can be obtained in the office. Never leave bags outside of the dumpsters do to dogs and other wildlife in the area. If it's too full, please contact the office to let them know.
- 22. Quiet hours will be from 11:00 pm till 8:00 am. Quiet hours will be strictly enforced.
- 23. Fireworks, firecrackers or other noise making "devices" are prohibited.
- 24. Registered site users are responsible for ensuring themselves and their guests obey all campground rules. Loud, abusive, or aggressive behavior will not be tolerated at any time and is cause for immediate eviction and being banned from returning without a refund. Remember, you and your guest may be asked to leave at any time by the campground manager.
- 25. Consumption of alcoholic beverages is restricted to your campsite or the Gazebo area only. Persons shall not walk about the campground carrying open alcoholic beverages.
- 26. Please do not climb, hang, nail, cut, or do any damage to the trees on the property.
- 27. All pets must be pre-approved by management first and must have a valid pet licence. Pets must be leashed at all times and must never be left un-attended at your site and

- must be cleaned up after. Noisy, unruly, aggressive, or disruptive pets will not be permitted to stay.
- 28. Patio lights must be plugged directly into your RV unit. Solar lighting is permitted. No ground wiring will be permitted.
- 29. Campground management must be notified if a camping unit from a seasonal site is being removed from the campsite for a day or longer.
- 30. Grass cutting will be done twice per week by campground staff, excluding weekends, and is dependent on the weather conditions. Please ensure that the lawn area is fully accessible for the use of the lawn tractors. If the lawn area to be cut is not accessible, campers will be responsible for their own lawn care.
- 31. For the safety of everyone extension cords / hoses etc are not permitted to be left (used) on the ground or placed underground.
- 32. Golf carts, ATVs, and side-by-sides are permitted in the campground, however only to be used to access the Silver Willow shotgun shooting facilities. Not for use around the campground. They must be parked on the gravel pad area not on the grass area.
- 33. Barbecues and their appropriate fuel are permitted.
- 34. Air Conditioners, generators, fans, heaters are not to be left running when absent from the park for more than 24 hours.
- 35. Summer Season fees are to be paid by April 1st. Late payments will be subject to a 300.00 fee + GST
- 36. Neither water nor power will be provided.
 - Port-A-Potties will be available on site.
 - Access to septic tank dumping is available via a mobile service, or in town at the Carstairs Campground located on the north end of town on highway 2A.
- 37. Shotguns when not in use on the course, must be safely stored in a case with a trigger lock on them in your vehicle or RV, and locked securely when you are away from your RV for any length of time.
- 38. Campers are asked to stay within the fenced camping area at all times and only access Silver Willow grounds during the club hours of operation.
- 39. Children can access the Silver Willow playground area when Silver Willow is operating, as long as a parent, guardian, or babysitter over 17 years of age remains there with them.

IMPORTANT: All Campground rules and regulations will be strictly enforced. Failure to comply with any of the campground rules and regulations will be considered a breach of the camping registration and may result in an immediate eviction, banning from the campground, and a loss of membership at Silver Willow Sporting Club, with no refunds.
